Description of Course Content: (3-0) The techniques of building construction, the communication of technical information, and the process of preparing contract drawings for construction. Prerequisite: ARCH 3343. Junior standing in program. Restricted to Architecture and Interior Design majors

Student Learning Outcomes: Develop basic skills needed to prepare architectural drawings for bidding and permitting.

Requirements: Regular attendance, course is treated as a hands-on workshop.

Required Textbooks and Other Course Materials: Reading materials will be provided by instructor.

Descriptions of major assignments and examinations with due dates:
Course work is the development of a set architectural drawings ready for building permit application. Assignments include zoning ordinance research, building code research, energy code compliance, accessibility compliance, occupancy and construction type determination and calculation of allowable area and allowable building height.

Grading Policy: Timely completion, technical accuracy, drawing clarity, and comprehensiveness of content shall be evaluated.

Attendance Policy: Regular attendance is required. For each 3 absences deduct one letter grade from final grade to be recorded for course.

Drop Policy: Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. After the late registration period, students must see their academic advisor to drop a class or withdraw.

Undeclared students must see an advisor in the University Advising Center. Drops can continue through a point two-thirds of the way through the term or session. It is the student's responsibility to officially withdraw if they do not plan to attend after registering. **Students will not be automatically dropped for non-attendance.** Repayment of certain types of financial aid administered through the University may be required as the result of dropping classes or withdrawing. Final Review Week: A period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week. The purpose of this week is to allow students sufficient time to prepare for final examinations. During this week, there shall be no scheduled activities such as required field trips or performances; and no instructor shall assign any themes, research problems or exercises of similar scope that have a completion date during or following this week *unless specified in the class syllabus*. During Final Review Week, an instructor shall not give any examinations constituting 10% or more of the final grade, except makeup tests and laboratory examinations. In addition, no instructor shall give any portion of the final examination during Final Review Week. During this week, classes are held as scheduled. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.
