Course Contents:

In Situ Test Methods, Advantages and Limitations, SPT, CPT, DCPT, CPTU or Piezocone, DMT, Pressuremeter, Shear Vane and Other Field Test Methods, Non-destructive Seismic, resistivity, electromagnetic methods, Soil Property Interpretation Procedures, Direct and Indirect Applications for Settlement Calculations.

Student Learning Outcomes:

To provide the graduate student with an understanding of various geotechnical intrusive “in situ” test methods and their interpretation procedures for soil properties and applications in geotechnical design.

In addition, this course will focus on the following students' abilities and educational outcomes:

- Ability to command basic and applied knowledge in geotechnical engineering.
- Ability to conduct independent and original studies, including gathering of information to propose, create, document the study and its resolution.
- Ability to critique and synthesize literature, review results and to apply this knowledge in developing new ideas; in designing and evaluating scientific investigations; and in assessing, interpreting and understanding data.

- Demonstrate mastery of the subject matter at a deeper theoretical and applied level beyond the fundamental knowledge gained in the undergraduate courses.
- Ability to present scientific results in written and oral formats to various forums.
- Improve interpersonal skills to become and good team players.
- Demonstrate interest in pursuing lifelong learning.

Required Text Book:

Major examinations: Two exams and one technical paper (with presentation) will be given.

One week of advance notice will be provided in scheduling the exams. Examinations will be either open book classroom or take home examinations.

The presentations by students are going to be made in the final review week (dead week).
