Description of Course Content: Techniques of melodic and rhythmic sightsinging and procedures of dictation.

Student Learning Outcomes: Students will learn to identify and implement the elements of Ear Training at a basic level and will learn the functioning principals of Ear Training in preparation for the subsequent course in the Ear Training sequence.

Attendance Policy: Students may have 2 unexcused absences in the semester without penalty. Points missed due to an excused absence will be reviewed on an individual basis. If an absence is foreseen, arrangements must be made early for homework assignments or exams. Sight Singing exams missed due to tardiness may be made up in front of the class on the following class meeting at a 10% deduction.

Classroom Behavior Policies:

Students must make every effort to come to class on time. Disturbances of entering classrooms after class has begun can disrupt the classroom environment, affecting both the professor and the student. Quizzes missed as a result of tardiness cannot be made up under any circumstance.

Students who create a discourteous environment will be asked to leave the classroom.

Drop Policy: Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. Final Review Week: A period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week.
