Time and Place of Class Meetings: This class meets weekly online in Blackboard. While most class participation is asynchronous, some synchronous online activities are required (dates to be announced). At semester end, there is a **mandatory three-day on-campus simulation experience: April 30, May 1, and May 2 (8-5 each day).**

Description of Course Content:

Clinical management of the high-risk neonate with a focus on the perinatal and transition periods as well as stabilization of the ill newborn at birth. Includes fluid and electrolyte management, nutrition, and identification of the indications and complications associated with invasive skills and procedures relevant to the high-risk neonate.

Other Requirements: Prerequisite: NURS 5315. As this course is offered in an online format, each student must have access to a computer and a high speed internet connection on a daily basis. Student Learning Outcomes:

1. Apply theoretical and empirical knowledge of developmental physiology of the fetus and newborn to the transition to extrauterine life.
2. Assess, diagnose, and plan for the management of health care needs of the high-risk maternal/fetal client using evidence-based knowledge.
3. Develop plans for health promotion and disease prevention in the care of the high-risk maternal/fetal client within their family system.
4. Analyze patient selection criteria, pathophysiology, and indications/contraindications in the performance of invasive skills.
5. Demonstrate NNP-specific skills.

1. **DRAFT:** The DRAFT SafeAssign feature allows you to check your paper for potential areas of plagiarism so that you may edit it prior to turning in your final submission. The SafeAssign DRAFT is not reviewed by your instructor. When you upload, please check the “submit as draft” option. The DRAFT box becomes available 72 hours prior to the final submission due date/ time and remains open until the date and time that the paper is due. At busy times, it may take up to 72 hours to receive a report.
2. **FINAL:** This Safe Assign location is separate and is the only one that will be graded. Only one document can be uploaded per SafeAssign. **The document you upload to the FINAL dropbox is the one that will be graded, so be certain it is the correct paper.**

Expectations of Out-of-Class Study: Beyond the time required to participate in class each week, students enrolled in this course should expect to spend at least an additional 9-12 hours per week on their own time in course-related activities, including reading required materials, completing assignments, preparing for exams, etc.

Attendance Policy: Regular class attendance and participation is expected of all students. Students are responsible for all missed course information.

Drop Policy: Graduate students who wish to change a schedule by either dropping or adding a course must first consult with their Graduate Advisor. If the author's ideas are rephrased, by transposing words or expressing the same idea using different words, the idea must be attributed to the author by proper referencing giving the author's name and date of publication. If a single author's ideas are discussed in more than one paragraph, the author must be referenced, according to APA format. Authors whose words or ideas have been used in the preparation of a paper must be listed in the references cited at the end of the paper. Final Review Week: A period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week.
