Description of Course Content: Techniques of melodic and rhythmic sight singing and procedures of dictation.

Student Learning Outcomes: Upon completion of this course, students will have learned the basics of Ear Training and enhanced their musicianship skills. They will be able to aurally identify and notate basic melodies, harmonic progressions, and rhythms, and be able to sight sing melodies using "moveable do" solfege.

Requirements: In addition to in-class exercises, students will be required to complete MacGamut assignments, email MacGamut statistics to the instructor, and prepare sight singing and rhythmic exercises prior to each class meeting.

Descriptions of major assignments and examinations: Assignments for the MacGamut software to be mastered for each unit are listed below (see "Levels to Master for MacGamut"); the number indicates you need to complete the indicated level in each of: Intervals, Chords, Melodic Dictation, and Harmonic Dictation. (Note: for Intervals and Chords exercises, use the "Make my own drill" feature to practice specific intervals or chord qualities you feel you need work on.) To master each level, you must complete 7 out of 10 drills to a specified degree of accuracy (6 out of 10 for the harmonic dictations). **At the end of each unit you will email your stats to me in your startup file.**

Unit 1

Intervals 1 – Melodic, 2nds + 3rds (2 choices) Chords 1 – M, m, root triads Melodic Dictation 1 – Major, I skips Harmonic Dictation 1 – I and V, root

Unit 2

Intervals 2 – add P4, P5, P8 (4 choices) Chords 2 –Add o, + triads Melodic Dictation 2 –Large I + V skips Harmonic Dictation 2 –add IV

Unit 3

Intervals 3 – add 6ths (6 choices)
Chords 3 –add 1st inversion (all)
Melodic Dictation 3 –cut time, IV skips, 6ths
Harmonic Dictation 3 –add 1st inversions

Unit 4

Intervals 4 – All melodic intervals (12 choices) Chords 4 –add 2nd inversion (all) Melodic Dictation 4 –larger IV skips Harmonic Dictation 4 –add ii/iio

Attendance: Regular and punctual class attendance is mandatory.

A student's grade will not be penalized for two unexcused absences. The third and fourth unexcused absences will lower the student's final grade by 10%, one letter grade, in addition to any missed assignments, quizzes, and exams. Students that miss five or more classes may receive a failing final grade. What constitutes an excused absence is at the discretion of the instructor, in compliance with the University's policies.
