Description of Course Content: This course is intended to provide an overview of modern genetic tools available to answer outstanding scientific questions in biology. Students will have access to genetic mutants of plants and bacteria to perform experiments using a variety of molecular techniques followed by computational/statistical analyses of the results.

Student Learning Outcomes: Upon completion of the course, students must be familiar with Good Laboratory Practice (GLP) guideline, understand how to perform hypothesis-driven research, design experiments, and develop written and oral communication skills to report research findings (scientific literacy).

Prerequisites: BIOL 1441, BIOL 3315 or equivalent.

Laboratory Requirements Students will be evaluated through a combination of quizzes, lab reports, a lab notebook, oral presentation, and participation.

Course Materials: reading assignments will be provided as the course progresses.

Final Review Week: A period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.
