I. Course Description

III. Objectives of the Course

This course provides the student with an understanding of the basic terminology, structure and importance of business finance. At the conclusion of the course the students will be able to:

- 1. understand time value of money and compute mortgage calculations using TVM techniques.
- 2. understand legal concepts in real estate including property rights, deeds, and leases etc.
- 3. understand the real estate market using demand and supply, urban economics, and appraisal.
- 4. differentiate between the three real estate appraisal methods.

Required Calculator:

A financial calculator is required for this course. Texas Instruments BA II Plus is recommended, since I will be teaching by using that model. HP 10-B or equivalent calculators could be used, but students are held accountable on learning how to master them. Financial, non-storing calculators will be the only ones allowed in the exams. Calculators must manipulate irregular cash flows

Please list your sources at the end of the paper so they can be verified. Type and proofread your paper before submission. Deductions will be made for grammar and spelling mistakes. Also, your fellow students will be asked about the quality and usefulness of each project submitted. You will also present your project during class time and answer questions.

There will be 2 surprise quizzes throughout the semester each carrying 5% weightage given in the beginning of the class meeting. Every student is REQUIRED to bring a scantron sheet every class to take the quiz.
