<u>**Time and Place of Class Meetings:**</u> Class will meet weekly online in Blackboard. While most class participation is asynchronous, some synchronous online activities are required (dates provided in Major Assignment section on page 2).

Description of Course Content:

This course focuses on preparation to implement an evidence-based change in practice.

<u>Other Requirements</u>: Prerequisites: NURS 5327 and NURS 5366. As this course is offered in an online format, **each student must have a computer with a high speed internet connection**. The computer should meet UTA's hardware recommendations:

This course requires the use of word processing and presentation software that is compatible with Microsoft Office formats. Students may purchase this software (in person or by mail) at a significant discount from the UTA bookstore <u>http://www.uta.edu/bookstore</u> (scroll to the bottom of the webpage). Students are required to have a headset (with microphone) and webcam to participate in web conferences and to test online. Testing will be done online using Respondus browser and monitor (which students must download from a link within Blackboard and install on their computer). The instructor will determine what option is offered to students who are unsuccessful in completing a test online. Students must pay a fee.

<u>Student Learning Outcomes</u>:

- 1. Search for appropriate literature to answer a clinical question.
- 2. Perform rigorous critique of evidence for nursing practice
- 3. Synthesize the literature to answer the clinical question.
- 4. Plan for the change in practice using an EBP model with a team.
- 5. Develop an evaluation plan for the change in practice.
- 6. Develop a plan to disseminate project results.

In this course, you will submit papers as Microsoft Word-compatible documents to **SafeAssign** in Blackboard. Review the student resources section on Blackboard for more information about the tool. You are encouraged to use the DRAFT function within SafeAssign prior to submitting your FINAL draft. See details below:

1. DRAFT: The DRAFT SafeAssign feature allows you to check your paper for potential areas of plagiarism so that you may edit it prior to turning in your final submission. The SafeAssign DRAFT is not reviewed by your instructor. When you upload, please check the "submit as draft" option. The DRAFT box becomes available 72 hours prior to the final submission due date/ time and remains open until the date and time that the paper is due. At busy times, it may take up to 72 hours to receive a report.

2. FINAL: This Safe Assign location is separate and is the only one that will be graded. Only one document can be uploaded per SafeAssign. The document you upload to the FINAL dropbox is the one that will be graded, so be certain it is the correct paper.

Expectations of Out-of-Class Study: Beyond the time required to participate in class each week, students enrolled in this course should expect to spend at least an additional 9-12 hours per week on their own time in course-related activities, including reading required materials, completing assignments, preparing for exams, etc.

<u>Attendance Policy</u>: At The University of Texas at Arlington, taking attendance is not required. Plagiarism: Copying another student's paper or any portion of it is plagiarism. Copying a portion of published material (e.g., books or journals) without adequately documenting the source is plagiarism. Consistent with APA format, if five or more words in sequence are taken from a source, those words must be placed in quotes and the source referenced with author's name, date of publication, and page number of publication. If the author's ideas are rephrased, by transposing words or expressing the same idea using different words, the idea must be attributed to the author by proper referencing giving the author's name and date of publication. If a single author's ideas are discussed in more than one paragraph, the author must be referenced, according to APA format. Authors whose words or ideas have been used in the preparation of a paper must be listed in the references cited at the end of the paper.
