**Description of Course Content:** The course presents selected topics in electric motor drives. In particular, this course covers different circuit topologies and control strategies for electromechanical energy conversion systems.

**Student Learning Outcomes:** This course is dealing with the building blocks and enabling technologies in Electric Motor Drives. Students will be able to analyze different classes of electrical machinery and inverter topologies, and switching patterns. They will be able to simulate and characterize different energy conversion systems using various simulation tools.

**Requirements:** Students are expected to be familiar with power electronics, power systems, and electrical machinery at an undergraduate level. Control theory, at a graduate level, will be desired. Students are required to be competent in working with Matlab/Simulink simulation environment. Otherwise, consent of the instructor is required.

## Descriptions of major assignments and examinations:

There will be three projects throughout this course. There will be no midterm or final exam. As an undergraduate student, you will be given a chance to participate in a 10% extra bonous project.

**Attendance:** Attendance and active participation in class is mandatory.

**Grading**: There will be four projects with increasing complexity, and they constitute 20%, 25%, 25%, and 30% of the final grades. The bonus project will be an additional 10%. Students are expected to keep track of their performance throughout the semester and seek guidance from available sources (including the instructor) if their performance drops below satisfactory levels. **Expectations for Out-of-Class Study**: A general rule of thumb is this: for every credit hour earned, a student should spend 3 hours per week beyond the time required to attend each class meeting, students enrolled in this course should expect to spend at least an additional 3 hours per week of their own time in course-related activities, including reading materials and simulation projects. Simulation of basic as well as more real life circuits in PSPICE or Matlab/Simulink might be developed and required
