**Student Learning Outcomes:** Acquiring the fundamental knowledge of Thermodynamics and Statistical Mechanics.

**Course Descriptions**: Fundamental principles of thermal dynamics and statistical mechanics, including kinetic theory, entropy, ensemble theory, and quantum statistical mechanics.

**Descriptions of major assignments and examinations:** The course will have about ten homework assignments, a mid-term exam and the final exam. Both exams are closed-book, but a formula sheet is allowed. The final exam is comprehensive.

Attendance: not required but strongly encouraged.

## Other Requirements: none.

**Course Plan** (tentative):

Review of thermodynamics, the problem of kinetic theory; (~2-3 weeks)

Equilibrium state, Maxwell-Boltzmann distribution (~2 weeks);

Classical statistical mechanics, ensemble theory; (~3 weeks)

Intermediate Exam: close-book problem solving. (TBA)

Quantum statistical mechanics; (~2 weeks)

Fermi system and Bose system (~3 weeks)

Final Exam: close-book problem solving, (2:00 pm-4:30pm Thursday. May 14).

## Grading Policy:

Homework: 40%.

Intermediate Exams: 25% (In the week of March  $2^{nd}$ )

Final Exam: 35%

**Drop Policy:** Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. **Final Review Week:** A period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week.
