Course Prerequisites: Math 1315 or equivalent.

Description of Course Content: The topics covered in this class include logarithms and exponential functions, math of finance, and differential and integral calculus. Chapters 9, 10, 11, 12, 13 in the textbook will be covered.

Learning Outcomes: Upon completion of Math 1316, the students should have an understanding of interest, annuities, differential and integral calculus, and be able to apply these mathematical tools to analyze business and economics problems.
