Course Content: Includes structural design of slender columns, walls, truss model for shear and torsion; structural systems such as continuous beams, two-way slabs, yield-line theory and shear friction. Behavior of reinforced concrete structures, with emphasis on ductility and detailing of frames, slabs, and detailing for seismic loads will be covered. Building codes, American Concrete Institute (ACI) specifications, material specifications, test methods, and recommended practice documents. Credit not granted for both CE 4361 and CE 5312
