Description of Course Content: Finite element method in the study of the static response of structures and of continua; applications to field problems; analytical methods emphasized, and digital computer application undertaken.

Student Learning Outcomes: After completing the course, the student should be able to

- Use the finite element method to analyze simple elastic structures using appropriate model idealization, discretization techniques, and element selection criteria
- Assess the quality of a finite element numerical solution and improve accuracy

Prerequisites: Graduate standing and knowledge of linear algebra

Required Textbooks and Other Course Materials: *A First Course in the Finite Element Method*, 5th ed., 2011, by Daryl Logan (must be U.S. edition—mixed English and S.I. units)

Homework: Weekly homework will be assigned. Homework submission deadlines and policies will be strictly enforced as follows:

- All homework assignments are due at the beginning of class
- All homework assignments must be clearly written on engineering paper using only one side of the paper
- Late homework will be accepted for 50% credit with the approval of the instructor (do not submit late assignments to the TA).
- No homework submission will be accepted beyond 72 hours after the deadline.
- Homework will not be accepted by email.

Make-up Exam Policy: There will be NO make-up exams except in extraordinary circumstances. Missed exams will receive a grade of zero unless the student has an excused absence.
