### • COURSE OBJECTIVE (Student Learning Outcomes)

A rigorous study of Probability – a basis for further studies in Random Processes, Statistics and Actuarial Sciences. Grasp phenomena whose outcome is left to chance. Gain insight toward applications in the areas of science, engineering, business, where predictions of random outcomes are desired.

**Follow-up class:** Stochastic Models and Simulation, MATH 4311, Spring 2016.

This class is a component of studies in Statistics, Industrial Math, Actuarial Sciences.

### • GRADING and SCHEDULE

Course grade will be based on 3 tests (70%) [tests announced a week in advance] and the Final exam (30%) based on standard scale A[90-100], B[80-89], C[70-79], D[60-69].

**ATTENDANCE POLICY:** To succeed in this class attendance is strongly recommended.

**Drop Policy.** Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. After the late registration period, students must see their academic advisor to drop a class or withdraw. Undeclared students must see an advisor in the University Advising Center. Drops can continue through a point two-thirds of the way through the term or session. **Final Review Week.** A period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week.
