**Description of Course Content:** Students are required to swim during each class session. Students will participate in a variety of swimming skills and strokes. Student assessment will consist of skill evaluation, personal improvement, and participation.

**Student Learning Outcomes:**

1. To learn to swim or learn to swim more efficiently.
2. To understand hydrodynamic principles as related to swimming.
3. To understand safety principles as they apply to swimming.

**Required Textbooks and Other Course Materials:** Access to the internet

**Descriptions of major assignments and examinations:**

- Participation: attendance counts for 5 points; effort and participation make up the remaining 5 points for a daily possible 10 points
- Skill completion tasks: 2 skills per 4-week session for 10 points each
- Time drop test: 25-yard swim for time (Midterm & Final)

**Attendance:** At The University of Texas at Arlington, taking attendance is not required but attendance is a critical indicator in student success. Each faculty member is free to develop his or her own methods of evaluating students' academic performance, which includes establishing course-specific policies on attendance. As the instructor of this section, I have established the following attendance policy: Students will receive 10 points for each class they participate in. A non-participation is considered an absence. A doctor's note for illness and/or injury will be accepted up to 2 absences. The note requires: the student's name, dates missed, and that the student is to not participate in physical activity. Students will not be allowed to participate if they are more than 10 minutes late to class. This will be considered an absence. However, while UT Arlington does not require instructors to take attendance in their courses, the U.S. Department of Education requires that the University have a mechanism in place to mark when Federal Student Aid recipients "begin attendance in a course." UT Arlington instructors will report when students begin attendance in a course as part of the final grading process. Specifically, when assigning a student a grade of F, faculty report the last date a student attended their class based on evidence such as a test, participation in a class project or presentation, or an engagement online via Blackboard. This date is reported to the Department of Education for federal financial aid recipients.

**Other Requirements:**

**Attire** - A swimsuit must be worn to every class. It is suggested that each student purchase their own goggles and swim cap (if needed). Hair must be securely pulled out of your face/eyes.

- Females: full coverage is required. It is recommended to purchase a one-piece, competitive style swimsuit, however a two piece with a full coverage rash-guard is acceptable.
- Males: swim trunks, jammers, or speedo. No athletic gear allowed nor underwear under swimwear.

### **Grading:**

Participation- 290 points

Skills- 80 points

Time Drop- 80 points

Total- 450 points

Students are expected to keep track of their performance throughout the semester and seek guidance from available sources (including the instructor) if their performance drops below satisfactory levels.

**Drop Policy:** Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. After the late registration period, students must see their academic advisor to drop a class or withdraw. Undeclared students must see an advisor in the University Advising Center. Drops can continue through a point two-thirds of the way through the term or session. It is the student's responsibility to officially withdraw if they do not plan to attend after registering. **Students will not be automatically dropped for non-attendance.** Repayment of certain types of financial aid administered through the University may be required as the result of dropping classes or withdrawing. **Student Feedback Survey:** At the end of each term, students enrolled in face-to-face and online classes categorized as "lecture," "seminar," or "laboratory" are directed to complete an online Student Feedback Survey (SFS). Instructions on how to access the SFS for this course will be sent directly to each student through MavMail approximately 10 days before the end of the term. Each student's feedback via the SFS database is aggregated with that of other students enrolled in the course. Students' anonymity will be protected to the extent that the law allows. UT Arlington's effort to solicit, gather, tabulate, and publish student feedback is required by state law and aggregate results are posted online. **Final Review Week:** for semester-long courses, a period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week. The purpose of this week is to allow students sufficient time to prepare for final examinations. During this week, there shall be no scheduled activities such as required field trips or performances; and no instructor shall assign any themes, research problems or exercises of similar scope that have a completion date during or following this week *unless specified in the class syllabus*. During Final Review Week, an instructor shall not give any examinations constituting 10% or more of the final grade, except makeup tests and laboratory examinations. In addition, no instructor shall give any portion of the final examination during Final Review Week. During this week, classes are held as scheduled. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.

**Emergency Exit Procedures:** Should we experience an emergency event that requires us to vacate the building, students should exit the room and move toward the nearest exit, which is located on the north side of the indoor pool. When exiting the building during an emergency, one should never take an elevator but should use the stairwells. Faculty members and instructional staff will assist students in selecting the safest route for evacuation and will make arrangements to assist individuals with disabilities.
