### **Course Description**

This course examines criminology and criminal justice issues as they relate specifically to women. The major areas of coverage include (1) women and girls as victims of crime, and (2) women and girls as criminal offenders.

### **Course Requirements**

<u>Exams</u>. There will be two online exams this semester. Each exam will be worth 100 points. The exams will be comprised of 50 multiple choice and true/false questions based on class lecture, assigned readings, documentaries and guest speaker presentations.

### Makeup Exam Policy

Makeup exams will be provided for students who have a university recognized excused absence. Excused absences include (but are not limited to): illnesses with a doctor's note, serious family emergency, special curricular requirements (e.g., field trips, conferences), participation in official university activities. Final decision of excused absences is left to the discretion of the instructor. In most instances, students will be required to provide written documentation for your absence. In addition, you **MUST** talk with me prior to the date of the exam in order to schedule a makeup. All makeup exams **MUST** be scheduled within one week of the original exam.

<u>Group Project.</u> Students will be required to participate in a group project. Groups will consist of 4-6 students who will work together to create a 20-minute presentation to the class. Further details will be discussed in class.

<u>Participation</u>. Although students are not required to attend class, it is strongly recommended that students do so to receive a high grade in this course. Participation is determined by being present in class (i.e., no cell phone use, side conversations with classmates, and excessive online use), contributing to class discussion, and having an *active* role in the required group project.

# **Course Policies**

Attendance - At The University of Texas at Arlington, taking attendance is not required but attendance is a critical indicator in student success. Each faculty member is free to develop his or her own methods of evaluating students' academic performance, which includes establishing course-specific policies on attendance. As the instructor of this section, attendance is required if you wish to receive a passing grade. If you miss a class it is strongly encouraged that you borrow one of your classmate's notes and then talk with me if you need additional clarification. *I do not provide students with my notes nor will I post notes/slides to the internet.* If you miss an exam or an assignment you must: (1) notify me within 24 hours AND (2) provide me with an acceptable excuse. Note that I may request written documentation. If you do not follow this procedure you will receive a zero on any assignment/examination you may miss due to absence. However, while UT Arlington does not require instructors to take attendance in their courses, the U.S. Department of Education requires that the University have a mechanism in place to mark when Federal Student Aid recipients "begin attendance in a course." UT Arlington instructors will report when students begin attendance in a course as part of the final grading process. Specifically, when assigning a student a grade of F, faculty report the last date a student attended their class based on evidence such as a test, participation in a class project or presentation, or an engagement online via Blackboard. This date is reported to the Department of Education for federal financial aid recipients.

Late Policy – Students are expected to complete all graded elements by the deadlines provided. Those deadlines will be enforced. Students may *NOT* submit a late exam, quiz, or assignment unless they contact me with proper documentation prior to the deadline, or within 24 hours in the event of a serious emergency. Examples include documented personal or immediate-family emergencies in regards to health and well-being, documented military deployment, documented emergency services work, and documented university activities. Keep in mind that simply missing class, emails, or BlackBoard announcements does not delay deadlines.

**Drop Policy:** Students may drop or swap (adding and dropping a class concurrently) classes through selfservice in MyMav from the beginning of the registration period through the late registration period. After the late registration period, students must see their academic advisor to drop a class or withdraw. Undeclared students must see an advisor in the University Advising Center. Drops can continue through a point two-thirds of the way through the term or session. It is the student's responsibility to officially withdraw if they do not plan to attend after registering. **Students will not be automatically dropped for non-attendance**. Repayment of certain types of financial aid administered through the University may be required as the result of dropping classes or withdrawing. **Student Feedback Survey:** At the end of each term, students enrolled in face-to-face and online classes categorized as "lecture," "seminar," or "laboratory" are directed to complete an online Student Feedback Survey (SFS). Instructions on how to access the SFS for this course will be sent directly to each student through MavMail approximately 10 days before the end of the term. Each student's feedback via the SFS database is aggregated with that of other students enrolled in the course. Students' anonymity will be protected to the extent that the law allows. UT Arlington's effort to solicit, gather, tabulate, and publish student feedback is required by state law and aggregate results are posted online. **Final Review Week:** for semester-long courses, a period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week. The purpose of this week is to allow students sufficient time to prepare for final examinations. During this week, there shall be no scheduled activities such as required field trips or performances; and no instructor shall assign any themes, research problems or exercises of similar scope that have a completion date during or following this week *unless specified in the class syllabus*. During Final Review Week, an instructor shall not give any examinations constituting 10% or more of the final grade, except makeup tests and laboratory examinations. In addition, no instructor shall give any portion of the final examination during Final Review Week. During this week, classes are held as scheduled. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.

**Emergency Exit Procedures:** Should we experience an emergency event that requires us to vacate the building, students should exit the room and move toward the nearest exit to your assigned classroom. When exiting the building during an emergency, one should never take an elevator but should use the stairwells. Faculty members and instructional staff will assist students in selecting the safest route for evacuation and will make arrangements to assist individuals with disabilities.
