Course Description:

EE 1106 INTRODUCTION TO ELECTRICAL ENGINEERING (1-2) A project based course in which basic concepts in electrical engineering, such as electrical systems, power and energy, circuit laws, measurements, and data analysis will be introduced. Student teams will engage in laboratory experiments, application hands-on projects, which cover areas of study in electrical engineering including analog and digital electronics, robotics, semiconductors, electromagnetics, signal processing, photonics, energy management, and telecommunication systems. Corequisites: EE 1104.

Descriptions of major assignments and examinations:

See Blackboard for a link to the course Wiki page. The Wiki page will have details on each lab and details about all assignments and exams.

There will be a writing assignment for each lab that may include computer circuit simulations and/or computer application development. There will be one quiz at the mid-point of the semester and another at the end.

Attendance: Because this is a lab course, **on-time attendance is mandatory**. You will sign in at the beginning of the class. The sign-in sheet will be taken down about 10-15 minutes into the lab and failure to sign-in will result in a zero for that lab and count against your attendance grade. Do not sign in for someone else and do not ask someone else to sign in for you.

While UT Arlington does not require instructors to take attendance in their courses, the U.S. Department of Education requires that the University have a mechanism in place to mark when Federal Student Aid recipients "begin attendance in a course." UT Arlington instructors will report when students begin attendance in a course as part of the final grading process. Specifically, when assigning a student a grade of F, faculty report the last date a student attended their class based on evidence such as a test, participation in a class project or presentation, or an engagement online via Blackboard. This date is reported to the Department of Education for federal financial aid recipients.

Drop Policy: Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. After the late registration period, students must see their academic advisor to drop a class or withdraw. Undeclared students must see an advisor in the University Advising Center. Drops can continue through a point two-thirds of the way through the term or session. It is the student's responsibility to officially withdraw if they do not plan to attend after registering. **Students will not be automatically dropped for non-attendance**. database is aggregated with that of other students enrolled in the course. Students' anonymity will be protected to the extent that the law allows. Final Review Week: for semester-long courses, a period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week. The purpose of this week is to allow students sufficient time to prepare for final examinations. During this week, there shall be no scheduled activities such as required field trips or performances; and no instructor shall assign any themes, research problems or exercises of similar scope that have a completion date during or following this week *unless specified in the class syllabus*. During Final Review Week, an instructor shall not give any examinations constituting 10% or more of the final grade, except makeup tests and laboratory examinations. In addition, no instructor shall give any portion of the final examination during Final Review Week. During this week, classes are held as scheduled. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.

Emergency Exit Procedures:
