# Time and Place of Class Meetings: Private Lessons: FA 244, MW (1hr weekly)

Studio Class: Room TBD, M 12:00 noon - 12:55 Clarinet Quartet: FA 244, F (1hr weekly)

**Description of Course Content:** This sequence of courses is required of music majors whose concentration is woodwinds. These courses are open to non-music majors as well. Private lessons will consist of three sections, all of which require weekly attendance and proper preparation. Section 1: Private Lessons, Section 2: Studio Class, Section 3: Clarinet Quartet

**Student Learning Outcomes:** The student will demonstrate knowledge of applicable solo/chamber music materials, an orientation to the fundamentals of pedagogy as pertaining to the instrument or area of study, and comprehensive capabilities in preparing and performing a solo/chamber piece at a high level.

Curricular Practical Training: Students are expected to seek professional opportunities as a part of this course. Participation and progress in these endeavors must be approved and overseen by applied instructor. Private instruction, participation in professional orchestras, and chamber music performance are examples of approved activities. These activities will be assessed as a percentage of the weekly lesson grade.

Required Textbooks and Other Course Materials: In order to be successful in all three sections of private lessons, you will need the following:

### MATERIALS

- A folder or three ring binder with ample pockets in which to store music
- A notebook or blank paper in a three ring binder on which to take notes
- A pencil pouch with pencils in it
- A metronome/tuner (I recommend having both a Korg TM-50 metronome/tuner to carry around in your bag and the Tonal Energy Tuner app on your smartphone)
- Several working reeds

- Artistic Studies, Book 1 From the French School: Cyrille Rose, Edited by David Hite
- Carl Baermann's Celebrated Method for Clarinet: Part 3, Revised and Edited by Jack Snavely
- Intermediate Velocity Studies for Clarinet: 33 Technical Etudes, by Kalmen Opperman
- Daily Practice Packet (assembled during the first lesson, given to the student by the professor)
- A Solo (chosen in the first lesson, to be purchased later)
- Clarinet Quartet parts (given to the student by the professor)

\*MAKE SURE to buy the correct EDITION of the texts as listed. The Baermann book has several editions out there and most of them are...well they're bad. BUY THE SNAVELY EDITION

\*\*Owning these three books should cost you under \$60, which is truly a cheap price for a college course text requirement when compared to many of your other classes. However, I understand the financial plight of the college student, AND the reality that the bookstore does not yet carry these three texts. So, I am including the IMSLP links to PDF copies of old editions of two of these texts with expired copyrights. DO NOT RELY on these copies forever, but they will get you started if you have trouble acquiring the texts in time for the first weeks of lessons.

## Descriptions of major assignments and examinations:

## **SECTION 1: PRIVATE LESSONS**

In preparation for your weekly private lesson, you are expected to practice daily the number of hours for which you have signed up per semester credit. So, theoretically, if you have signed up for 2 credit hours of private lessons, you should practice 2 hours a day. 3 credit hours equals 3 hours of daily practice, etc. Through that preparation, you will be expected to "pass off" 10 items from the required materials/texts section in order to receive an A for the private lessons portion of your grade. The available "pass off" items are:

- 1) Daily Practice Packet\*
- 2) One etude from the Artistic Studies (at indicated tempo)
- 3) One major or minor key from the Baermann book (scales bpm=120, arpeggios/3rds bpm=80)
- 4) One Velocity Study (at indicated tempo)
- 5) Any other item Dr. Cruz deems worthy

\*The Daily Practice Packet must be completed first, before other items may be attempted. Theoretically you will be playing through this packet every day, and it will be appropriate to your skill set and level, so this should be perfectly manageable.

## SECTION 2: STUDIO CLASS

Every week on Mondays at noon, we will all meet as a studio. Your attendance is required. There will also be various studio events throughout the semester that will require your attendance. (For example, Diane Barger and Denise A. Gainey will be performing as the <u>Amicita Duo on Monday October 3<sup>rd</sup> at 4pm and giving a master class at 5pm</u>. My faculty recital is <u>September 17<sup>th</sup> at 5:30pm</u> in Irons Recital Hall). Exceptions may be made only in EXTREME circumstances, and all absences must be approved beforehand with at least 24 hours notice.

Students enrolled in private lessons are expected to play <u>at least two times</u> in studio class, and we will generate a schedule for the semester in the first few weeks of classes. Studio class performances do not necessarily have to be with piano, nor do they have to be performances of full pieces. Not every studio class will be performance oriented either; some days will be dedicated to a lecture about reeds, a presentation on how to deal with performance anxiety, guest artist master classes, etc. Our first studio class meeting will be **Monday, August 29**<sup>th</sup> **at noon**.

## **SECTION 3: CLARINET QUARTETS**

Every student enrolled in private lessons is required to be a part of a clarinet quartet (or possibly a trio depending on the odd/even number of students involved). I believe chamber music in small groups is vital to the development of your musicianship, especially if you plan on teaching music in any capacity. Quartets will be formed based on skill/maturity level and will be loosely based on your ensemble placements. Pre-formed groups will likely be approved if there are four willing participants who would like to perform together, and the top clarinet quartet will be expected to perform outside of UTA. There are endless performance opportunities in DFW with a small chamber ensemble, and several of them WILL PAY!

All the clarinet quartet groups will meet weekly for a coaching with me on Mondays or Wednesdays (we will schedule these coachings in the first few weeks of classes just like we will schedule your private lessons.) All clarinet quartet groups will perform on a chamber studio recital at the end of the semester. **December 2<sup>nd</sup> at 6:30** is the performance date for Fall 2016, and the **dress rehearsal** is reserved on **November 30<sup>th</sup> at 9pm**. The performance is required, dress rehearsal optional but recommended. If your group cannot perform at the recital for some reason, I may approve an off campus performance in lieu. Granted requests are not guaranteed.

Attendance: Attendance at every private lesson is required. Make up times for missed lessons will be on Mondays, Wednesdays, or Fridays with my approval. Attendance at all studio classes is required. Students may be granted absences if requested in advance because of extreme circumstances. Attendance at every weekly clarinet quartet coaching is required. Make up times for missed clarinet quartet coachings will be on Mondays, Wednesdays, or Fridays with my approval. Every missed lesson, studio class, or quartet coaching without advanced approval or make up time scheduled will result in the loss of a <u>FULL LETTER GRADE</u>. Email me in advance, take care of your schedule, show up to class, and don't miss lessons.

**Grading:** Your letter grade will be determined by four unequal factors:

### 1) PRIVATE LESSONS: 60%

Your private lesson grade is based on how many items from the "pass off" section you complete throughout the semester. Whether or not you complete a "pass off" item is determined subjectively by me, but I will take into consideration how well the item was prepared, if the item was at the appropriate tempo, whether or not you fully understood the content of the item, and whether or not your own musicality/creativity was present in the performance of the item. The grading rubric is as follows:

9 items = A- (91)
8 items = B (89)
7 items = B- (81)
6 items = C (79)
5 items = C- (71)
4 or less is unsatisfactory for private lessons

## 2) END OF SEMESTER JURY: 20%

At the end of the semester you will be required to perform a Jury for the woodwind faculty consisting of a performance with piano of the solo piece we chose for you in private lessons. The woodwind faculty members will assess your performance subjectively and assign it a letter grade.

#### 3) STUDIO CLASS PERFORMANCES: 10%

You are required to perform at least two times in studio class. These performances do not have to be full pieces nor do they have to be with piano. You will receive an A for showing up and blowing air through your horn. We will discuss your performance as a studio in class.

#### 4) CLARIET QUARTET: 10%

You are required to perform once with your clarinet quartet. I have reserved a recital date as mentioned earlier in the syllabus, and if you cannot attend we will find an outside venue for you to perform. You will receive an A for showing up and playing your part.

**Grade Grievances:** Any appeal of a grade in this course must follow the procedures and deadlines for grade-related grievances as published in the current University Catalog.

Drop Policy: Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. After the late registration period, students must see their academic advisor to drop a class or withdraw. Undeclared students must see an advisor in the University Advising Center. Drops can continue through a point two-thirds of the way through the term or session. It is the student's responsibility to officially withdraw if they do not plan to attend after registering. **Students will not be automatically dropped for non-attendance**.
