Description of Course Content: Basic concepts and definitions, properties of pure substance, work and heat, first law of thermodynamics, second law of thermodynamics, entropy, and introduction to conductive, convective, and radiative transfer.

Student Learning Outcomes: To study fundamental concepts of thermodynamics and heat transfer. To develop skills and techniques essential in analyzing and solving engineering problems involving thermal energy.

Required Textbooks and Other Course Materials: Introduction to Thermodynamics and Heat Transfer, 2nd Ed. by Yanus A. Cengel

Descriptions of major assignments and examinations:

(a) Quizzes:

- In-class pop-quizzes
- No makeup work for any missed quizzes!

(b) Homework:

- Must be hand-delivered to the classroom.
- All homework that is obviously transcribed will receive a score of zero.
- There might be homework due in the final review week.
- No late homework is accepted.

(c) Exams:

- 2 midterms and 1 final (3 exams total)

- Closed books/Closed notes
- Students can prepare one equation sheet (letter-sized)

- No make-up exam for unapproved absence

Attendance: At The University of Texas at Arlington, taking attendance is not required but attendance is a critical indicator in student success. Each faculty member is free to develop his or her own methods of evaluating students' academic performance, which includes establishing course-specific policies on attendance. As the instructor of this section, I will take attendance sporadically. However, while UT Arlington does not require instructors to take attendance in their courses, the U.S. Department of Education requires that the University have a mechanism in place to mark when Federal Student Aid recipients "begin attendance in a course." UT Arlington instructors will report when students begin attendance in a course as part of the final grading process. Specifically, when assigning a student a

grade of F, faculty report the last date a student attended their class based on evidence such as a test, participation in a class project or presentation, or an engagement online via Blackboard. This date is reported to the Department of Education for federal financial aid recipients.

Other Requirements: C or better in each of the following: MATH 2425 (or HONR-SC 2425) and PHYS 1444.

Grading:

- Quizzes: 5% (Bonus points)
- Homework: 10%
- Exams: 30% each, 90% in total

Drop Policy: Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. After the late registration period, students must see their academic advisor to drop a class or withdraw. Undeclared students must see an advisor in the University Advising Center. Drops can continue through a point two-thirds of the way through the term or session. It is the student's responsibility to officially withdraw if they do not plan to attend after registering. **Students will not be automatically dropped for non-attendance.** Repayment of certain types of financial aid administered through the University may be required as the result of dropping classes or withdrawing. Student Feedback Survey: At the end of each term, students enrolled in face-to-face and online classes categorized as "lecture," "seminar," or "laboratory" are directed to complete an online Student Feedback Survey (SFS). Instructions on how to access the SFS for this course will be sent directly to each student through MavMail approximately 10 days before the end of the term. Each student's feedback via the SFS database is aggregated with that of other students enrolled in the course. Students' anonymity will be protected to the extent that the law allows. UT Arlington's effort to solicit, gather, tabulate, and publish student feedback is required by state law and aggregate results are posted online. Final Review Week: for semester-long courses, a period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week. The purpose of this week is to allow students sufficient time to prepare for final examinations. During this week, there shall be no scheduled activities such as required field trips or performances; and no instructor shall assign any themes, research problems or exercises of similar scope that have a completion date during or following this week *unless specified in the class syllabus*. During Final Review Week, an instructor shall not give any examinations constituting 10% or more of the final grade, except makeup tests and laboratory examinations. In addition, no instructor shall give any portion of the final examination during Final Review Week. During this week, classes are held as scheduled. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.

Emergency Exit Procedures: Should we experience an emergency event that requires us to vacate the building, students should exit the room and move toward the nearest exit which are located at either end of the hallway. When exiting the building during an emergency, one should never take an elevator but should use the stairwells.
