Description of Course Content: Basic theoretical musical concepts and keyboard skills relating to jazz and popular music including: scales, harmony, harmonic progressions, etc.

Prerequisite: MUSI 1325 or faculty approval.

Student Learning Outcomes: Upon successful completion of this course, students will be able to:

- Write/spell/play chords and voicings from a given jazz chord symbol
- Write/spell/play scales and modes studied in this course
- Associate scales and modes with their respective jazz chord symbols
- · Discuss and analyze standard jazz forms and chord progressions
- Perform basic jazz chord progressions on the keyboard

Descriptions of major assignments and examinations: Homework will be given during each class. Unless otherwise noted, it will be due during the following class meeting. See the course outline at the end of this syllabus for major assignments and due dates.

Attendance: At The University of Texas at Arlington, taking attendance is not required but attendance is a critical indicator in student success. Each faculty member is free to develop his or her own methods of evaluating students' academic performance, which includes establishing course-specific policies on attendance. As the instructor of this section, I will take attendance and each student will be allowed two (2) unexcused absence during the course of the semester. The instructor reserves the right to deduct points from the final semester grade if satisfactory attendance is not met. Attendance will be taken at the start of each class meeting. If you are not in class by the time attendance is taken, you will be counted absent that day.

However, while UT Arlington does not require instructors to take attendance in their courses, the U.S. Department of Education requires that the University have a mechanism in place to mark when Federal Student Aid recipients "begin attendance in a course." UT Arlington instructors will report when students begin attendance in a course as part of the final grading process. Specifically, when assigning a student a grade of F, faculty report the last date a student attended their class based on evidence such as a test, participation in a class project or presentation, or an engagement online via Blackboard. This date is reported to the Department of Education for federal financial aid recipients.
