Description of Course Content: This is a student-driven special topics seminar course featuring themes in behavioral ecology and ethology. Topics will include: predator-prey interactions, sexual selection & courtship behavior, parental care, migration & dispersal, social behavior & altruism, aggression & conflict, innate vs. learned behavior, behavioral science applications, cognition (in non-human animals), and evolutionary psychology (in humans).

Student Learning Outcomes: Students will become familiar with the historical progression of paradigm shifts and evolving research methods in this relatively young field of study. They will come to understand how varied behavioral responses across a diverse array of species (including our own) have been shaped by evolution in an ecological context. Students will obtain practice with library research, including exposure to foundational and contemporary primary literature in ethology and behavioral ecology. Students will also hone their oral presentation skills.

Descriptions of major assignments and examinations: Students will lead class discussions based on assigned readings. Students are expected to keep up with readings and participate in class discussions. More than half of our class time will be set aside for student term presentations based on library research. Each student will be assigned a presentation theme and a group of possible study organisms, but each will narrow their topic further based on library research and individual consultations with the instructor. Guidelines outlining expectations for assignments will be available on the first day of class.

- 30% participation (leading one readings-based discussion session, and participating in others)
- 30% term project ~25 minute oral presentation (or 40 min presentation w/partner); bibliography
- 30% final exam (synthesis of course themes; short answer / essay format)
