Grade Components: There will be three tests and a comprehensive final exam.

Course Description: In this course we will be studying real numbers, the completeness property, the supremum property, sequences and series, limits of functions, continuous functions, and uniform continuity, etc.

Expectations: You are expected to thoroughly read the appropriate sections in the textbook, understand all definitions, theorems, and relevant examples in the book that are covered in the lectures. You are expected to work out all assigned homework problems and turn in on time. You will be expected to continue your development of rigorous proof skills. Group discussions in and out of the classroom is encouraged. I expect that you spend at least 9 hours each week on Math 3335 outside the classroom.
