<u>COURSE DESCRIPTON</u>: Agent-based modeling and simulation provides a systematic way to explore macroscopic behaviors of the complex system (e.g., behavior patterns) that derived from microscopic modeling mechanisms (e.g., individual characteristics and behaviors). In this course, we will learn fundamental concepts of the agent-based modeling and gain hands-on experiences of using simulation toolkit AnyLogic<sup>®</sup> to model and simulate real-world complex systems. Through the course, we will introduce a series of essential topics including, but not limited to, when agent-based models are most appropriate to employ, what is agent-based modeling, how to conceptualize and formulize agent-based models, and how to implement the computer simulation model in AnyLogic. To achieve all this, we will have detailed discussions on several relevant examples and papers that cover various application areas (e.g., health care, supply chain, manufacturing, etc.).

There is no pre-requisite for this course, however it is very helpful if you have some programming experience in Java.

LEARNING OUTCOMES: By the end of this course, you should

- be familiar with the design concepts of agent-based modeling
- be able to create your own agent-based models
- be proficient with AnyLogic

## **COURSE TOPICS:**

- 3 How to create your own agent-based models?
- 4 What are the basic components of agent-based models?
- 5 How to select and assign model parameters of an agent-based model?
- 6 How to construct the agent-based model in AnyLogic?
- 7 How to analyze the result of an agent-based model?

## **ASSIGNMENTS:**

- **Project (200 points):** You will be partnered with two of your classmates to design and implement your own agent-based project. The project is the key assignment of this course. Eight (8) sub-assignments will be given based on specific requirements for the project. The project topics will be discussed in the early stage of the course and the detailed instructions for each sub-assignment will be provided in the class.
- **Discussion and Participation (50 points):** Discussion is required to keep the classes interactive and interesting. Please plan to attend each class.

## **GRADING POLICY:**

A >= 85% (of the total points); B >= 75%; C >= 60%; D >= 50%; F < 50%.

**Late Submissions:** Late submission of assignments is subject to a 20% reduction of points per school day, e.g., one day late of a 10-point homework will be assessed to a 2-point reduction. Late work will not be accepted after five school days.
