**Description of Course Content:** Intensive review of the mathematics necessary for graduate work in finance, with application to selected areas of business finance, investment analysis and financial markets. Prerequisite: FINA 5311.

## **Student Learning Outcomes:**

1. Find the arbitrage-free value for a contingent claim in the binomial model.

- 2. Solve stochastic differential equations using Ito calculus.
- 3. Determine whether a stochastic process is a martingale.
- 4. Derive the Black-Scholes partial differential equation
- 5. Derive the Black-Scholes European call option pricing model.

**Required Textbooks and Other Course Materials:** *Arbitrage Theory in Continuous Time, Third Edition,* Tomas Bjork, Oxford University Press, New York, 2009

**Descriptions of major assignments and examinations:** Three unit exams and a cumulative final exam.

Attendance: Highly recommended.

**Grading**: Each exam represents 25% of the student's grade.

**Drop Policy:** Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period.
