## • GRADING and SCHEDULE

Course grade will be based on 3 tests (70%) [tests announced a week in advance] and the final exam (30%) based on standard scale A[90-100], B[80-89], C[70-79], D[60-69].

**ATTENDANCE POLICY:** To succeed in this class attendance is strongly recommended.

**Drop Policy.** Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period.
