**Description of Course Content:** Techniques for analyzing upper bounds for algorithms and lower bounds for problems. Problem areas include: sorting, data structures, graphs, dynamic programming, combinatorial algorithms, introduction to parallel models.

**Student Learning Outcomes:** At the end of this course you must be able to:

- master the algorithms and algorithmic techniques covered;
- argue correctness and analyze the running time of a given algorithm;
- design new algorithms for new situations, using as building blocks the algorithms and techniques learned; and
- prove a problem is NP-complete using reduction.

**Required Textbooks and Other Course Materials:** Introduction to Algorithms by Cormen, Leiserson, Rivest, Stein., 3rd ed., MIT Press, 2009.

**Descriptions of major assignments and examinations:** There will be four in-class quizzes and two non-comprehensive exams. For additional details, see the grading policy below.

**Attendance:** At The University of Texas at Arlington, taking attendance is not required but attendance is a critical indicator in student success. Each faculty member is free to develop his or her own methods of evaluating students' academic performance, which includes establishing course-specific policies on attendance. As the instructor of this section, I have decided that attendance at class meetings is not required but strongly encouraged. However, while UT Arlington does not require instructors to take attendance in their courses, the U.S. Department of Education requires that the University have a mechanism in place to mark when Federal Student Aid recipients "begin attendance in a course." UT Arlington instructors will report when students begin attendance in a course as part of the final grading process. Specifically, when assigning a student a grade of F, faculty report the last date a student attended their class based on evidence such as a test, participation in a class project or presentation, or an engagement online via Blackboard. This date is reported to the Department of Education for federal financial aid recipients.

**Grading:** Your grade will be calculated as follows:

- Quizzes: 30%

- There will be 4 short quizzes during the course to test your understanding of the concepts taught
- They will generally be allotted 15-20 minutes at the end of the class period
- They will be announced at least a week in advance
- Midterm: 35%
  - There will be one midterm exam during the semester covering first half of the course
  - There will be no make-up exams except under extenuating circumstances!
- Final: 35%
  - There will be one non-comprehensive final exam during the semester covering second half of the course
  - There will be no make-up exams except under extenuating circumstances!

Students are expected to keep track of their performance throughout the semester and seek guidance from available sources (including the instructor) if their performance drops below satisfactory levels; see “Student Support Services,” below.

**Make-up Exams:** Make-ups for graded activities may be arranged if your absence is caused by illness or work/personal emergency. A written explanation (including supporting documentation) must be submitted to the Instructor. If the explanation is acceptable, an alternative to the graded activity will be arranged. Make-up arrangements must be arranged prior to the scheduled due date.

**Expectations for Out-of-Class Study:** Beyond the time required to attend each class meeting, students enrolled in this course should expect to spend at least an additional 9 hours per week of their own time in course-related activities, including reading required materials, completing assignments, preparing for exams, etc.

**Drop Policy:** Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. After the late registration period, students must see their academic advisor to drop a class or withdraw. Undeclared students must see an advisor in the University Advising Center. Drops can continue through a point two-thirds of the way through the term or session. It is the student's responsibility to officially withdraw if they do not plan to attend after registering. **Students will not be automatically dropped for non-attendance.** Repayment of certain types of financial aid administered through the University may be required as the result of dropping classes or withdrawing. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.
