**Description of Course Content:** This course is for the graduate-level students to study the background in the methodologies, mathematics and algorithms in machine learning or who may need to apply machine learning techniques to scientific applications (e.g. computer vision, bioinformatics, data mining, information retrieval, natural language processing, etc).

**Student Learning Outcomes:** Understanding the machine learning algorithms, implement some of them in the programming projects.

**Required Textbooks and Other Course Materials:** Pattern Recognition and Machine Learning, Christopher M. Bishop, 2006.

**Descriptions of major assignments and examinations:** The programming project sets will be assigned in class. Each student will also select one paper to read and present in class.

**Drop Policy:** Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. **Student Feedback Survey:** At the end of each term, students enrolled in face-to-face and online classes categorized as “lecture,” “seminar,” or “laboratory” are directed to complete an online Student Feedback Survey (SFS). Instructions on how to access the SFS for this course will be sent directly to each student through MavMail approximately 10 days before the end of the term. Each student’s feedback via the SFS database is aggregated with that of other students enrolled in the course. Students’ anonymity will be protected to the extent that the law allows. **Final Review Week:** for semester-long courses, a period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week. The purpose of this week is to allow students sufficient time to prepare for final examinations. During this week, there shall be no scheduled activities such as required field trips or performances; and no instructor shall assign any themes, research problems or exercises of similar scope that have a completion date during or following this week *unless specified in the class syllabus*. During Final Review Week, an instructor shall not give any examinations constituting 10% or more of the final grade, except makeup tests and laboratory examinations. In addition, no instructor shall give any portion of the final examination during Final Review Week. During this week, classes are held as scheduled. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.
