**Description of Course Content:** The fundamental laws of heat and mass transfer, including steady and unsteady state conduction, convection, and radiation. Applications of heat transfer to thermal systems design are included. Required course. Prerequisites - MAE 3360, MAE 2314, MAE 3310.

**Student Learning Outcomes:** (A) An ability to apply knowledge of math, science, and engineering, (B) An ability to design a system, component, or process to meet desired needs, (C) An ability to identify, formulate, and solve engineering problems, (D) Recognition of the need for and an ability to engage in life-long learning, (E) An ability to use the techniques, skills and modern engineering tools necessary for engineering practice

**Required Textbooks and Other Course Materials:** Fundamentals of Heat and Mass Transfer, 8th edition by Bergman, Levine, Incropera, and DeWitt (John Wiley & Sons, New York).

(b) Homework:

- Assigned during lectures and due at the beginning of the first lecture in the immediately following week.
- Must be hand-delivered to the classroom.
- If not explicitly stated otherwise, each homework problem will be graded out of 10 points.
- All homework that is obviously transcribed will receive a score of zero.
- There might be homework due in the final review week.
- No late homework is accepted.

(c) Exams:

- No make-up exam for unapproved absence

**Attendance:** At The University of Texas at Arlington, taking attendance is not required but attendance is a critical indicator in student success. Each faculty member is free to develop his or her own methods of evaluating students' academic performance, which includes establishing course-specific policies on attendance. As the instructor of this section, I will take attendance sporadically. However, while UT Arlington does not require instructors to take attendance in their courses, the U.S. Department of Education requires that the University have a mechanism in place to mark when Federal Student Aid

recipients "begin attendance in a course." UT Arlington instructors will report when students begin attendance in a course as part of the final grading process. Specifically, when assigning a student a grade of F, faculty report the last date a student attended their class based on evidence such as a test, participation in a class project or presentation, or an engagement online via Blackboard. This date is reported to the Department of Education for federal financial aid recipients.

**Student Feedback Survey:** At the end of each term, students enrolled in face-to-face and online classes categorized as "lecture," "seminar," or "laboratory" are directed to complete an online Student Feedback Survey (SFS). Instructions on how to access the SFS for this course will be sent directly to each student through MavMail approximately 10 days before the end of the term. Each student's feedback via the SFS database is aggregated with that of other students enrolled in the course. Students' anonymity will be protected to the extent that the law allows. **Final Review Week:** for semester-long courses, a period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week. The purpose of this week is to allow students sufficient time to prepare for final examinations. During this week, there shall be no scheduled activities such as required field trips or performances; and no instructor shall assign any themes, research problems or exercises of similar scope that have a completion date during or following this week *unless specified in the class syllabus*. During Final Review Week, an instructor shall not give any examinations constituting 10% or more of the final grade, except makeup tests and laboratory examinations. In addition, no instructor shall give any portion of the final examination during Final Review Week. During this week, classes are held as scheduled. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.
