Course Description

Catalog description: EE 3317 LINEAR SYSTEMS (3-0) For non-electrical engineering majors. Classes meet concurrently with EE 3316.

Catalog description: EE 3316. CONTINUOUS AND DISCRETE SIGNALS AND SYSTEMS. 3 Hours. Time-domain transient analysis of continuous and discrete signals. Continuous and discrete-time convolution, state-space analysis, frequency domain analysis, Laplace transforms and transfer functions, signal flow and block diagrams, Bode plots, stability criteria, Fourier series and transforms. Stability analyses of causal and non-causal systems using the Z-transform. Sampling and Introduction to Digital Control. Finite Impulse Response (FIR) digital filter design. Design of frequency selective Infinite Impulse Response (IIR) digital filters using frequency transformations and the bilinear transform. Applications from control systems and signal processing. Problems and numerical examples using MATLAB.

Attendance

At The University of Texas at Arlington, taking attendance is not required but attendance is a critical indicator in student success. Specifically, when assigning a student a grade of F, faculty report the last date a student attended their class based on evidence such as a test, participation in a class project or presentation, or an engagement online via Blackboard. This date is reported to the Department of Education for federal financial aid recipients.

Make-up Exams

There is no make-up exam for this course.

Expectations for Out-of-Class Study

A general rule of thumb is this: for every credit hour earned, a student should spend 3 hours per week beyond the time required to attend each class meeting, students enrolled in this course should expect to spend at least an additional 3 hours per week of their own time in course-related activities, including reading materials and simulation projects. Simulation of basic digital communication components in Matlab/Simulink will be required for several assignments.

Drop Policy

Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. After the late registration period, students must see their academic advisor to drop a class or withdraw. Undeclared students must see an advisor in the University Advising Center. Drops can continue through a point two-thirds of the way through the term or session. It is the student's responsibility to officially withdraw if they do not plan to attend after registering. **Students will not be automatically dropped for non-attendance.** Repayment of certain types of financial aid administered through the University may be required as the result of dropping classes or withdrawing. Student Feedback Survey

At the end of each term, students enrolled in face-to-face and online classes categorized as 'lecture,' 'seminar,' or 'laboratory' are directed to complete an online Student Feedback Survey (SFS). Instructions on how to access the SFS for this course will be sent directly to each student through MavMail approximately 10 days before the end of the term. Each student's feedback via the SFS database is aggregated with that of other students enrolled in the course. Students' anonymity will be protected to the extent that the law allows. Final Review Week

For semester-long courses, a period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week. The purpose of this week is to allow students sufficient time to prepare for final examinations. During this week, there shall be no scheduled activities such as required field trips or performances; and no instructor shall assign any themes, research problems or exercises of similar scope that have a completion date during or following this week unless specified in the class syllabus. During Final Review Week, an instructor shall not give any examinations constituting 10% or more of the final grade, except makeup tests and laboratory examinations. In addition, no instructor shall give any portion of the final examination during Final Review Week. During this week, classes are held as scheduled. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.

Emergency Exit Procedures
