Description of Course Content:

German 2314 is a three-hour course in German language and culture aimed at reaching an intermediate proficiency level (ACTFL-Intermediate Mid) at the end of the semester. Prerequisite: GERM 2313 with a grade of C or better.

Course Objectives:

Students will practice listening, reading, speaking, and writing. Grammatical functions will be analyzed and vocabulary will be learned to facilitate spoken and written communication. The culture and geography of German-speaking countries will also be explored. This course will strive to engage students in the appreciation and acceptance of language, culture, cross-cultural dialogue, and change in an increasingly global society.

Student Learning Outcomes:

Interpretive Communication

- o Students can understand the main idea and key information in short and straightforward texts.
- o Students can identify the main idea and key information in short and straightforward conversations.

Interpersonal Communication

- Students can exchange information and interact with others in conversations on familiar topics and some researched topics, creating sentences and series of sentences and asking a variety of followup questions.
- Students can exchange preferences, feelings, or opinions and provide basic advice on a variety of familiar topics, creating sentences and series of sentences and asking a variety of follow-up questions.

Presentational Communication

- The student can tell a story about his life, activities, events and other social experiences, using sentences and series of connected sentences.
- The student can state his/her viewpoint about familiar topics and give some reasons to support it, using sentences and series of connected sentences.
- The student can give straightforward presentations on a variety of familiar topics and some concrete topics he/she has researched, using sentences and series of connected sentences.

Attendance:

At The University of Texas at Arlington, taking attendance is not required but attendance is a critical indicator in student success. Specifically, when assigning a student a grade of F, faculty report the last date a student attended their class based on evidence such as a test, participation in a class project or presentation, or an engagement online via Blackboard. This date is reported to the Department of Education for federal financial aid recipients.

Students are expected to keep track of their performance throughout the semester and seek guidance from available sources (including the instructor) if their performance drops below satisfactory levels; see "Student Support Services" below.

Make-up Exams: Make-up exams are given only in the case of emergencies and require documentation. Any other considerations will be made on a case-by-case basis. When possible, please notify me in advance of absences on scheduled exam dates. No quizzes will be made up. However, the quiz with the lowest grade will be dropped.

Drop Policy: Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. After the late registration period, students must see their academic advisor to drop a class or withdraw. Undeclared students must see an advisor in the University Advising Center. Drops can continue through a point two-thirds of the way through the term or session. It is the student's responsibility to officially withdraw if they do not plan to attend after registering. **Students will not be automatically dropped for non-attendance**. Repayment of certain types of financial aid administered through the University may be required as the result of dropping classes or withdrawing. Final Review Week: for semester-long courses, a period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week. The purpose of this week is to allow students sufficient time to prepare for final examinations. During this week, there shall be no scheduled activities such as required field trips or performances; and no instructor shall assign any themes, research problems or exercises of similar scope that have a completion date during or following this week *unless specified in the class syllabus*. During Final Review Week, an instructor shall not give any examinations constituting 10% or more of the final grade, except makeup tests and laboratory examinations. In addition, no instructor shall give any portion of the final examination during Final Review Week. During this week, classes are held as scheduled. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.
