Description of Course Content:

- CE 5353: Flow resistance, gradually-varied flows, St. Venant equations, numerical solutions of gradually-varied flows and St. Venant, hydrologic routing
- CE 4330: Design methods for appurtenances of water conveyance systems under open channel and pressure flow conditions.

Student Learning Outcomes: Upon completion of this course, students should be able to:

- Apply principles of mass balance, energy, and momentum to open channels.
- Calculate normal and critical depths and understand the importance of these parameters in open channel flows.
- Design hydraulic structures such as spillways, energy dissipaters, weirs, culverts.
- Understand and be able to predict unsteady flows in rivers.
- Understand numerical schemes and computer models to simulate open channel flows.
- Understand and analyze pipe flows.
- Analyze and design pipe systems.

Descriptions of major assignments and examinations with due dates:

Homework:

Homework assignments will be given throughout the semester. The completion of these assignments is an essential means of achieving the learning outcomes. Problem sets are due a week later unless otherwise specified. Late problem sets will not be accepted. Solutions are to be done neatly with answers clearly indicated and with all equations used clearly written. Key assumptions must be stated. Missed homework will count as zero and may not be submitted by other students.

Exams: There will be a mid-term exam and the final exam.

The instructor reserves the right to adjust the grade distribution, policy and structure. Expectations for Out-of-Class Study: Beyond the time required to attend each class meeting, students enrolled in this course should expect to spend at least an additional 4-6 hours per week of their own time in course-related activities, including reading required materials, completing assignments, preparing for exams, etc.
