Description of Course Content: This course introduces students to basic concepts and techniques in computer vision. The topics covered include morphological operations, connected component analysis, image filters, edge detection, feature extraction, object detection, object recognition, tracking, gesture recognition, image formation and camera models, calibration, and stereo vision. A strong programming background is assumed, as well as familiarity with linear algebra (vector and matrix operations), and knowledge of basic probability theory and statistics.

Student Learning Outcomes: Upon successful completion of this course, students will understand and have a mastery of the following topics: state of the art computer vision techniques and applications, setting up a computer vision programming environment, data acquisition and display, image thresholding, morphology, motion detection and tracking, object recognition, camera calibration and fiducial markers, depth and 3D sensing techniques and hardware, point clouds, segmentation, registration, performance considerations, parallel processing, and emerging technologies.

Required Textbooks and Other Course Materials: All required materials will be provided by the instructors through blackboard and github.

Descriptions of major assignments and examinations: The final letter grade for this course will be based on scores received on homework assignments. Homework assignments are to be submitted electronically via Blackboard. Late assignments will be accepted with a 20% penalty applied for each day late up to 2 days. Assignments submitted later than 2 days after the original deadline will not be accepted.

Attendance: Class attendance will be recorded at the beginning of lecture sessions, but will not factor into the final course grade. Students who do not regularly attend lecture sessions risk missing valuable material, such as homework solutions and demonstrations. Regular attendance of class lectures is strongly encouraged.

Grading: Final course grades will be computed as an average of all homework assignments, all weighted equally. Each homework will be 20% of the final grade.

2-Week Grade Grievance Policy: Once a grade has been posted, you will have 2 weeks to contest your grade with whoever graded that assignment. The GTA will grade the Homework and Programming Assignments, and the Instructor will grade quizzes and exams. Once a grade has been posted for 2 weeks, the grade is final and will not be changed.

Make-up Assignments: Make-up assignments will only be allowed under extraordinary circumstances and must be approved by the instructor, whose decision is final. If an assignments is missed due to unavoidable circumstances, the instructor must be notified of the situation as soon as possible. Travel will not be considered as a valid excuse for missing an assignments, unless for the purpose of representing the university or department. Any assignments that are missed due to unexcused reasons will receive an automatic grade of zero.

Drop Policy: Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. After the late registration period, students must see their academic advisor to drop a class or withdraw. Undeclared students must see an advisor in the University Advising Center. Drops can continue through a point two-thirds of the way through the term or session. It is the student's responsibility to officially withdraw if they do not plan to attend after registering. **Students will not be automatically dropped for non-attendance**. Repayment of certain types of financial aid administered through the University may be required as the result of dropping classes or withdrawing.
