Description of Course Content: This course examines the grammatical structures of Modern English on the level of phrase and sentence

Student Learning Outcomes: By the end of the semester, students who have fully engaged in the course will have gained

- An understanding of the rules underlying English phrases and sentences
- The ability to represent these structures in Chomsky-style diagrams
- Awareness of the differences between prescriptivism and descriptivism
- Familiarity with topics in linguistics, including dialect differences and language acquisition in children and adults
- Above all, the confidence to teach from any grammar textbook used in the secondary schools and to work as editors or writing coaches

Required Textbooks and Other Course Materials:

- No textbook to purchase. We generate our own one chapter at a time in in-class explorations.
- My own practice manual will be made available on Blackboard

Descriptions of major assignments and examinations:

- four midterm exams (20% of course grade each)
- in-class opportunities to raise the cumulative exam score
- a final exam (20%)

Attendance: At The University of Texas at Arlington, taking attendance is not required but attendance is a critical indicator in student success. Each faculty member is free to develop his or her own methods of evaluating students' academic performance, which includes establishing course-specific policies on attendance.

As the instructor of this section, I will take attendance every time. To be counted present after a late arrival, you must inform me of your presence before leaving the class room.

My Policy: Missing six class meetings will lower the course grade by one letter grade. I do not distinguish between excused and unexcused absences, so these six will have to cover all unforeseen events, i.e. illness, car trouble, traffic jams, family emergencies, and all the other things beyond our control.

And please remember that you are always responsible for anything covered or announced in class, even if you weren't there that day.

However, while UT Arlington does not require instructors to take attendance in their courses, the U.S. Department of Education requires that the University have a mechanism in place to mark when Federal Student Aid recipients "begin attendance in a course." UT Arlington instructors will report when students begin attendance in a course as part of the final grading process. Specifically, when assigning a student a grade of F, faculty report the last date a student attended their class based on evidence such as a test, participation in a class project or presentation, or an engagement online via Blackboard. This date is reported to the Department of Education for federal financial aid recipients.

Drop Policy: Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. After the late registration period, students must see their academic advisor to drop a class or withdraw. Undeclared students must see an advisor in the University Advising Center. Drops can continue through a point two-thirds of the way through the term or session. It is the student's responsibility to officially withdraw if they do not plan to attend after registering. **Students will not be automatically dropped for non-attendance.** Repayment of certain types of financial aid administered through the University may be required as the result of dropping classes or withdrawing. Student Feedback Survey: At the end of each term, students enrolled in face-to-face and online classes categorized as "lecture," "seminar," or "laboratory" are directed to complete an online Student Feedback Survey (SFS). Instructions on how to access the SFS for this course will be sent directly to each student through MavMail approximately 10 days before the end of the term. Each student's feedback via the SFS database is aggregated with that of other students enrolled in the course. Students' anonymity will be protected to the extent that the law allows. UT Arlington's effort to solicit, gather, tabulate, and publish student feedback is required by state law and aggregate results are posted online. Final Review Week: for semester-long courses, a period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week. The purpose of this week is to allow students sufficient time to prepare for final examinations. During this week, there shall be no scheduled activities such as required field trips or performances; and no instructor shall assign any themes, research problems or exercises of similar scope that have a completion date during or following this week *unless specified in the class syllabus*. During Final Review Week, an instructor shall not give any examinations constituting 10% or more of the final grade, except makeup tests and laboratory examinations. In addition, no instructor shall give any portion of the final examination during Final Review Week. During this week, classes are held as scheduled. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.

Emergency Exit Procedures: Should we experience an emergency event that requires us to vacate the building, students should exit the room and move toward the nearest exit, which is located at the east end of our corridor. An outside staircase takes us above ground floor. When exiting the building

during an emergency, one should never take an elevator but should use the stairwells. Faculty members and instructional staff will assist students in selecting the safest route for evacuation and will make arrangements to assist individuals with disabilities.
