Description of Course Content: Time and frequency domain analyses of linear time invariant systems. Discrete-time convolution. Stability analysis of causal and non-causal systems using the Z-transform and Discrete Fourier Transform (DFT). Sampling and reconstruction. Finite Impulse Response (FIR) and infinite impulse response (IIR) digital filter design. Discrete Fourier transform and fast Fourier transform algorithm. Discrete time random processes and spectrum estimation. The use of a practical DSP algorithm implementation running on an embedded microcontroller. Prerequisite: Grade of C or better in both EE 2441 and EE 3316 or EE 3417

Student Feedback Survey: At the end of each term, students enrolled in face-to-face and online classes categorized as "lecture," "seminar," or "laboratory" are directed to complete an online Student Feedback Survey (SFS). Final Review Week: for semester-long courses, a period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week. The purpose of this week is to allow students sufficient time to prepare for final examinations. During this week, there shall be no scheduled activities such as required field trips or performances; and no instructor shall assign any themes, research problems or exercises of similar scope that have a completion date during or following this week *unless specified in the class syllabus*. During Final Review Week, an instructor shall not give any examinations constituting 10% or more of the final grade, except makeup tests and laboratory examinations. In addition, no instructor shall give any portion of the final examination during Final Review Week. During this week, classes are held as scheduled. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.
