Description of Course Content: This course is designed for engineers and managers involved in infrastructure development, sustainability, and replacement. Topics include asset management, inspection, evaluation, maintenance, and renewal alternatives for waste collection and water distribution systems, surface and subsurface drainage, pavements, bridges, culverts, buildings, and other structures. Credit not granted for both CE 4302 and CE 5345. Prerequisite: CE 4347, CE 4348or equivalent.

Student Learning Outcomes: The course objective is to prepare students to demonstrate sound engineering judgment for evaluating, maintaining, and rehabilitating infrastructure related components.

Specific Course Learning Outcomes: Upon completion of the course, the student will:

- 1. Demonstrate the ability to identify causes of failures for a variety of infrastructure assets.
- 2. Understand the difference between maintenance, rehabilitation, and repair of most civil engineering types of infrastructure.
- 3. Analyze complex problems to identify potential methods to repair, rehabilitate and restore damaged infrastructure.
- 4. Understand the importance of communicating research results through class discussions, presentations, and reports.
- 5. Understand the benefits of integrating the infrastructure evaluation, maintenance, and renewal process into a good asset management program.

All outcomes are observed implicitly through class participation, exams, homework, reports and formal/informal communications with instructor.

Descriptions of major assignments and examinations with due dates: Homework assignments, review of **three** peer-reviewed articles assignment, a research paper, presentation, one mid-term exam and a comprehensive final exam.

All assignments must be turned in at the start of the class **Hard Copy** for in-class students and electronically (uploaded into Blackboard) for Distance Learning students or special arrangements for inclass students, prior to the class period in which they are due. Failure to do so will constitute a grade of zero for the assignment in question.

One week of advanced notice will be provided in scheduling each exam. The final exam will be given according to the university's published final exams schedule. Note that failure to appear for an exam at the scheduled time will constitute a grade of zero in that exam.

Homework, articles review, and paper in this class are the minimum assignments considered adequate to achieve basic proficiency of course material. Homework will be discussed in class. Format for Homework:

• Other format: Homework is to be typewritten (font 12) unless noted otherwise by the instructor; Include at the beginning of the problem, the problem statement and any diagrams given as well as any additional diagram needed to solve the problem. then show the solution. If calculations are required, all calculations should show two (2) significant figures for intermediate values calculated. Final answer should be rounded to two (2) significant figures unless all data is greater than three (3) significant figures. When establishing elevations or distances for design drawing, answers must be in hundreds of a foot or thousands of a meter.

The exams will generally relate to the material covered in the <u>lectures, handouts, assignments/HW and</u> <u>AR.</u> The philosophy of the exam is not to merely test your total recall or memorization, but to extend your thinking from theory and example problems to engineering situations. Each exam may include both open and closed book portions.

See the "Make-up Exam and Assignment Policy" section for accommodations of incomplete or missed assignments.

Attendance: At the University of Texas at Arlington, taking attendance is not required but attendance is a critical indicator in student success. Each faculty member is free to develop his or her own methods of evaluating students' academic performance, which includes establishing course-specific policies on attendance. I have elected to take attendance till Census Day but will not factor attendance into the grade. "Students registered for Sections 001 are expected to attend <u>all</u> classes. Class participation and discussions are essential for full professional development and credit, as applicable.

Grading Policy: Grades are based on two exams, articles review (AR), assignments, group research paper, and presentation. Grades will be determined by averaging the exams and assignments as follows.

The presentation will cover the research topic. Proper spelling, use of clear and concise sentences on essay questions will also be considered in the grading process. Grade standards are as follows: 100 $\geq A \geq 90$, Less than 90> B ≥ 80 , Less than 80> C ≥ 70 , Less than 70> D ≥ 60 , and Less than 60> F ≥ 0 . Students are expected to keep track of their performance throughout the semester and seek guidance from available sources (including the instructor) if their performance drops

Expectations for Out-of-Class Study: Beyond the time required to attend each class meeting, students enrolled in this course should expect to spend at least an **additional 9 hours** per week of their own time in course-related activities, including reading required materials, completing assignments, preparing for exams, etc.

Research Paper: Students/assigned groups will submit a research topic in construction project management for approval by **September 14.** The research paper will cover a thorough review of a case study or research covering one or more areas of the topics listed in the assigned class book as approved by the instructor. The research paper will be completed and turned in at the beginning of the class on **November 30** at the start of the scheduled class.

The research paper will be between 10 to 12 pages long double spaced with font 12 (Arial or Times New Roman), one inch margins. Its format and style guidelines shall follow UTA's Thesis and Dissertation (T&D) Guidelines that can be found at: <u>https://www.uta.edu/gradstudies/</u>using the **Turabian** or APA Styles and shall cover at a minimum:

- Introduction
- Discussion of the case study or the research topic
- Findings and conclusion
- References (minimum 10 or as approved by instructor) and proper citations

Cover sheet, abstract/executive summary, table of content and appendices/attachments are not considered part of the total pages.

Proper spelling, use of clear and concise sentences, structure, and compliance with UTA's formatting requirements will be considered in the grading process.
