Description: This course covers the motion (position, velocity, acceleration) and interaction

of machine components within kinematic linkages using vector algebra and modern engineering tools. Fundamental concepts of kinematics and dynamics applied to the determination of degree of freedom mechanisms and forces acting on joints of mechanisms. Specific mechanisms and applications such as multi-

body mechanisms, linkage synthesis, cam design, and balancing.

Student This course is intended to enhance students' learning in the following areas: *i*) students will be able to identify degree of freedom of linkage system,

Attendance: At The University of Texas at Arlington, taking attendance is not required but attendance is a critical indicator in student success.
